- * 100% Disability (Recent Social Security Award Letter or benefits planning Query printout from the Social Security Office or 2 different doctor's letters stating total disability and expected duration of disability)
- * 100% DAV (Bring car tag letter provided by the VA that states that you are 100% **PERMANENTLY AND TOTALLY DISABLED** DUE TO SERVICE CONNECTED DISABILITIES
